1 TO THIS HONORABLE COURT, ALL PARTIES AND THEIR COUNSEL OF
2 RECORD, AND OTHER PARTIES IN INTEREST:

3 The Receiver hereby files the attached Final Determination of Investor Claims as a
4 prelude to filing a Motion for Approval of Final Distribution to Investors of receivership estate
5 funds.

6 Pursuant to this Court's April 9, 2021 Order, the filing of this Notice of Final
7 Determination of Investor Claims and Investor Distribution starts the clock for the limited
8 number of investors who filed written challenges to the Receiver's claims determination, which
9 were not fully accepted or were denied (a universe of 40 out of roughly 3,000 investors). These
10 investors may file written objections with the Court within 14 days of this filing. The Receiver
11 will respond to any objections within seven days, and then the Court will grant or deny the
12 investors' objections. Once that process is complete, the Receiver will file a Motion for
13 Approval of a Final Distribution to Investors.

14 **I. Background**

15 On April 9, 2021, the Court entered an Amended Order Denying in Part and Granting in
16 Part Receiver's Motion for Approval of Proposed Distribution Method and Procedures (ROA
17 #505) (the "Order"). Although the Order denied the Receiver's request to conduct an interim
18 distribution to investors at that time (primarily based on the objection of defendant Thomas
19 Maney), it approved the Receiver's proposed claim determination and distribution method and
20 procedures. The Receiver then complied with the procedures for determining the investor claims
21 set out in the Order:

22 1. A preliminary determination of each investor's claim was calculated based on the
23 records available to the Receiver. Each investor's claim was comprised of the total that the
24 investor paid into the Galileo Project and the Capital Improvement Fund (the "Preliminary
25 Determination of Claims").


26 2. Notice of these determinations was provided to the investors through: (i) a notice
27 posted on the Receiver's website, (ii) emails to investors (where email contact information is
28 available), and (iii) letters sent via the U.S. mail to investors.

1 final determination. These investors have 14 days from this filing to file a written objection with
2 the Court (the “Court Objection Bar Date”).¹ After 14 days, the Receiver will respond within
3 seven days to any investors who filed a written objection. Pursuant to the Order, the Court will
4 make the final determination of any investor’s written objections filed with the Court. When that
5 has occurred, a distribution can be made.
